

Terms and Conditions

- **1. Introduction** Welcome to Avidity ("we," "our," or "us"). By accessing or using our website and services, you agree to comply with and be bound by these Terms and Conditions. If you do not agree with these terms, please do not use our services.
- 2. Pricing All prices listed on our website are in U.S. Dollars (USD).
- **3. Refund Policy** We offer refunds under the following conditions:
 - Items must be returned within **30 days** of purchase.
 - Items must be in their original condition, unused, and in original packaging.
 - Refunds will be processed to the original payment method within 7-10 business days of receiving the returned item.
 - Shipping charges are non-refundable unless the return is due to our error.
 - Digital products, gift cards, and personalized items are non-refundable.

4. Shipping & Delivery Policy

- We exclusively ship via **UPS**.
- Orders are processed within 1-3 business days.
- Standard shipping takes **3-7 business days** within the U.S.
- International shipping times vary and may take **7-21 business days**, depending on the destination.
- Shipping rates are calculated at checkout based on the destination and package weight.
- We are not responsible for delays due to carrier issues or customs clearance for international orders.
- Any items sold that are subject to import/export restrictions will not be shipped in any
 manner that violates those restrictions. At the time of publication of these Terms and
 Conditions, we do not currently sell or ship any items subject to restriction.
- **5. Return Policy & Process** If you are not satisfied with your purchase, you may return it under the following conditions:
 - The return must be initiated within **30 days** of purchase.
 - Items must be unused, undamaged, and in their original packaging.
 - To initiate a return, contact our customer service at [Your Contact Email] to receive a return authorization.
 - Customers are responsible for return shipping costs unless the item is defective or incorrect.
 - Once the return is received and inspected, a refund or store credit will be issued.



Processing the return and payment refund may take up to 21 days.
